- Invoice deposit payments are due within **24-32 hours** of your invoiced being requested. Failure to pay the deposit within one weeks will result in the cancellation of the invoice, requiring a new quote to be provided and is subject to an administrative (fee if applicable)
- The remaining balance is due **upon completion**, not upon collection unless collection is within 2 business days of being notified of completion.
- Balance funds need to be clear before items can be shipped or collected.
- Please notify us via email once payment are made.

2. Payment Confirmation and Balance:

- Upon clearance of deposit funds, a receipt of payment will be emailed.
- Full payment receipt will be provided upon receipt of the balance payment. Please keep a photo of your jewellery and a photo of you wearing your jewellery (clearly showing your face) for insurance records.
- In-person card payments are accepted using IZettle.

3. Delivery Timeline and Deposit:

- Normal delivery for commissions, remodels, and bespoke work is 4-6 weeks or 5-8 weeks (depending on the job type) from the date of **cleared deposit payment**, not the invoice creation date.
- A minimum deposit of 50% (or 60% for some jobs) is required before work can commence, with the remaining balance due **upon completion**. Please notify us via email once the deposit payment is made.
- The payment date on the invoice is the estimated completion date and therefore the estimated balance payment date.

4. Refunds and Modifications:

- All commissions, bespoke, remodels, or work outlined in this document are non refundable.
- All deposits for commissions, bespoke, remodels, or work outlined in this document are non-refundable or exchangeable.
- Once materials have been ordered, the order cannot be cancelled.
